 - Online Forms
 - Vendor Agnostic
 - Prefer if it is Integrated with EMR/Patient Portal

- Patient Experience
 - Marketing/Promotion Patient Education
 - Email & Telehealth Consents
 - Telehealth 1st Contact Checklist
- Provider & Staff Training
 - Script for call initiation & wrap-up
 - Workflow focused
- Billing/Coding in Practice Management System
- Regulations, Legal, & Liability
 - HIPAA Compliant Solution
- Process Improvement

Security Challenges & HIPAA Compliance

- HIPAA Compliant Accessibility
 - Sustainable
- Zoom HIPAA Compliant Version, Custom Domain
 - ZoomBombing & Security
 - Background patients walking by an open door
- Video recording the Telehealth Consent
- Cloud storage may not be HIPAA compliant
- Recommendation: Do Not store Pics/forms on local computer
 - Second Camera to Snap picture of patient & Ins Card with integration to Practice Management System

- Online Forms
